## Giving at Holy Trinity





Holy Trinity Ripon is a fully inclusive church for the whole community. We seek to welcome all, whether you count yourself a Christian, or are just looking.

We want people to come to Holy Trinity Ripon to worship and grow in their faith; we also want people to feel welcomed to enjoy some of the fellowship and community events we arrange too. We hope you will notice that we do not overly or overtly request donations: we don't hand around a collection plate at our services; we don't generally, formerly charge for refreshments; and many of our events are free.

We do, however, need resources to undertake the work we do. If you would like to give, you can do this in several ways:

- Via a standing order mandate through your bank.
- At services there is usually a plate at the back of church for you to place any contribution
- In various locations you will notice small donation tins these are predominantly for refreshment donations
- If your donation exceeds £30, please consider gift aiding. Gift Aid envelopes are available
- Using the card machine located in the Narthex
- You can scan the QR code on the back of this document

If you plan to become a regular worshipper at Holy Trinity, it really helps us to budget if we know what regular donations we are likely to receive. To make a regular donation, please refer to the information in the rest of this document, cut out the relevant box or boxes. Send the yellow bank form to your bank and the green Gift Aid form back to Holy Trinity Church.

Of course, we hope that you might also consider giving by volunteering. We have lots of different ways we can use your talents. Please let the office know if you want to know more about serving in this way.

Please treat as Gift Aid donations all qualifying gifts of money made from the date of this declaration and in the past four years. - no longer pay sufficient tax on your income and or capital gains (Gift Aid is linked to basic rate tax)

Basic rate tax is currently 25% which currently allows charities to reclaim 25p in the pound. Higher rate taxpayers can claim back the difference between basic rate and higher rate and want to receive the additional tax relief due to you, you must include all your Gift Aid donations on your self assessment tax return, or ask HMRC to adjust your tax code.
